1. LAYER 1: COOKIE NOTICE

1.1. BANNER

This website only uses technical cookies with the purpose of optimizing the website and ensuring its correct functioning. It does not collect or transfer personal data from users.

2. LAYER 2: EXTENSIVE POLITICS

2.1. USE OF COOKIES. WHAT ARE COOKIES?

Cookies are files that are downloaded to your Computer, Smartphone or Tablet when accessing certain web pages, which store and retrieve information when you browse. The use of cookies offers numerous advantages in the provision of Information Society services, since, among others:

- (a) facilitates user navigation on the Website;
- (b) provides the user with access to the different services offered by the Website;
- (c) prevents the user from reconfiguring the general predefined characteristics each time they access the Website;
- (d) favors the improvement of the operation and of the services provided through the Website, after the corresponding analysis of the information obtained through the installed cookies;
- (e) allow a Website, among other things, to store and retrieve information about the browsing habits of a user or their equipment and, depending on the information they contain and the way in which you use your equipment, they can be used to recognize the user.

In accordance with the provisions of Law 34/2002, of July 11, on Information Society Services and Electronic Commerce, and Regulation (EU) 2016/679 of the

European Parliament and of the Council of April 27, 2016, we inform that this website does not use cookies to collect user information. Cookies are only used for technical and personalization purposes, in order to allow your navigation and to enable you to determine your preferences.

In order to provide you with the maximum possible information, we proceed, first of all, to classify the cookies, based on a series of categories:

Types of cookies according to the entity that manages them:

a) Own Cookies:

They are those for which the editor itself is responsible and which, generally, are sent to the user's terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided.

b) Third Party Cookies:

They are those for which an entity other than the publisher is responsible and which, generally, are sent to the user's terminal equipment from a computer or domain that is not managed by the publisher, but by another entity that processes the data obtained through the cookies.

Types of cookies according to their purpose:

- a) Technical cookies: these are those that allow the user to navigate through a web page, platform or application and use the different options or services that exist therein, including those that the editor uses to allow the management and operation of the website and enable its functions and services, such as, for example, controlling traffic and data communication, identifying the session, accessing restricted access parts, carrying out the purchase process, creating, storing content, for the dissemination of videos or sound, enable dynamic content, etc.).
- b) Preference or personalization cookies: these are those that allow the user to remember information so that the user can access the service with certain

characteristics that can differentiate their experience from that of other users, such as, for example, the language, the number of results to be shown when the user performs a search, etc.

- c) Analysis or measurement cookies: these are those that allow the person responsible for them to monitor and analyze the behavior of the users of the websites to which they are linked, including the quantification of the impacts of the advertisements.
- d) Behavioral advertising cookies: these are those that store information on user behavior obtained through continuous observation of their browsing habits, which allows the development of a specific profile to display advertising based on it.

Types of cookies according to the period of time they remain activated:

- a) Session cookies: these are those designed to collect and store data while the user accesses a web page. They are usually used to store information that is only interesting to keep for the provision of the service requested by the user on a single occasion (for example, a list of products purchased) and disappear when the session ends.
- b) Persistent cookies: these are those in which the data continues to be stored in the terminal and can be accessed and processed for a period defined by the person responsible for the cookie, which can range from a few minutes to several years.
